ENVIRONMENTAL BULLETIN:

The State Air Resources Board (ARB) will be holding hearings in the months ahead on whether to designate Henry Cowell Redwoods State Park, The Forest of Nisene Marks State Park and Pinnacles National Monument as Class I areas, the most restrictive of three air quality designations. The parks currently are Class II areas, which allow more pollutants than Class I. There will be considerable controversy over the tighter restrictions, since the results could influence the future of the air quality of many State and National Parks. CSPRA will be active in monitoring the hearings, and will request the CSPRA Board of Directors to take positive action on the issue at our December Board Meeting.

I attended the annual rendevous of National Park Rangers in Branson, Mo. on the 10th & 11th and 14th of October.

I was present at the opening ceremony that featured as guest speaker Russ Dickenson, Director N.P.S. His speech was mainly about the direction the National Park Service should direct itself. Urban parks, smaller units than usually associated with National parks, also the Ranger image. All in all it was a speech that Jack Knight, Earl Hanson and several directors in California Parks and Recreation have been making over the years with some variation.

Editorial

Internal Investigation Policy Stalled

Nine months ago, I first read a draft copy of suggested quidelines for "Internal Investigations". The author, Alan F. Crum, had begun the project to fill a void he saw in our department's administrative policies. I agreed and was looking forward to doing an article on the final product. He had pulled this draft together from varied sources to make the mechanics of an investigation clear and immediately available. It was, he felt, necessary to have a working policy as a tool for the reviewing officer as well as informing employees being investigated of what to expect.

After reading this 7 page package of dynamite and noting the half page "route to:" list of nearly everyone in our department, I decided to wait and see what action was taken. That was nine months What happened? I did reflect momentarily that this was the same department that took over 2 years to recognize the Peace Officer Bill of Rights as part of the manual. Last week I telephoned Al Crum, S&E Specialist at Region III. to see what had happened to the proposed policy recommendation. He said it hadn't gone anywhere. A few people made comments, all but one, very positive. He was not sure why this important item had not advanced further. However, when asked, he said that S&E Specialists last met about two years ago, and no meeting was scheduled currently.

The CSPRA Newsletter vigorously encourages the four new Regional Directors to promote development of formal procedures and quidelines for internal affairs & investigations. A tool is needed for reviewing managers and all employees should know what to expect, should they become involved. To maintain the professionalism we all promote, State Park employees are entitled to the presentation of a sound policy which maintains confidence and trust between members of the department, and the public.

The ANPR seems to follow the lines of CSPRA. Problems seem to be about the same. They being controlled by Congress. State Parks by Legislature. If you shook them all up in a bag, they would come out looking the same. Probably the biggest difference and biggest problem is the great distance the members of ANPR must travel. From Alaska to Florida is one great amount of travel.

I attended meetings and was recognized as a CSPRA member, (the nameplate did it and I have shorter hair). I enjoyed the meeting very much.

Next years meeting plans are tenatively for the West Coast.

I'm enclosing some of the literature and brochures put out by ANPR.

FIGHT BACK!!


