The team of Bob Todd, Craig Burke, John Hillerman and Steve Michael, have an opportunity to compete in the National championship match in Des Moines, Iowa but needed financial support. CSPRA gave each participant a \$150 scholarship if they attended and would agree to participate in the 1982 GEC and prepare an article for the Newsletter.

Pricing Us Out Of Promotions

It has happened to me -- and I know it has happened to many other park rangers -- where we simply cannot afford to promote. The cost of housing throughout this state of ours is a cause for many park rangers to refuse promotions. This is hurting our department, our parks, and our morale.

A recent article in <u>TIME</u> magazine painted a very clear picture of our situation -- but a different profession was being interviewed.

The reason this young person, age 30, left California was because he "...realized he could never afford to buy a home in California". He was making almost \$19,000 a year.

His manager stated that people in the same profession (elsewhere in the U.S.) are rejecting jobs in California because of housing costs. His "company" has decided to construct 144 condominiums and town houses to help alleviate this problem.

Maybe you are wondering about this "company" I have referred to. The answer is, "... Until the <u>University of California</u>, with its <u>many campuses</u>, comes up with cheaper housing, it is likely to suffer a continuing <u>brain drain</u>."

It is so easy to substitute the words <u>parks</u> department and <u>many parks</u> -- and we too have a <u>brain drain</u> of sorts -- since capable rangers cannot move upward.

A progressive program to install <u>adequate</u>, <u>livable</u> mobile home pads would be a start in the right direction.

Editor's note: If you have <u>not</u> applied for a promotion or transfer because of similar housing economics, please let me know.



AGAINST RAILWAY COMPANY

Illegal work at lagoon may draw fine

SANTA BARBARA — California Coastal Commission has directed its legal department to determine what action should be taken against the Atchison, Topeka & Santa Fe Railway Co. for illegal work it did near Batiquitos Lagoon.

The commission last Friday also withheld approval of a maintenance project undertaken by the railway company.

The company could be fined or asked to take steps to reduce damage caused by repair work done on a railroad trestle near the lagoon, which lies between Leucadia and Carlsbad.

The railway company extended a maintenance road to the trestle to access by trucks and other maintenance vehicles to do repair work.

But in doing so, the company placed a large amount of fill—estimated by commission staff to be 700 feet wide and as much as 30 feet high—in the lagoon, according to a commission spokesman.


The result, he said, is a road with loose dirt around it and a high potential for erosion and subsequent runoff of sedimentation into the lagoon.


Commission staff analyst Paul Webb said the fill that has been placed in the lagoon is not currently a serious problem but will be when the rainy season begins and the fill is washed into the lagoon.

CSPRA OPPOSES TORREY PINES THREAT EIC Testifies and Asks Support

CSPRA Environmental Issues Committee member Rick Parmer addressed the San Diego City Council on October 13 regarding the proposed condominium development adjacent to Torrey Pines SR. Two other organizations also represented were Torrey Pines Protective Association and the Torrey Pines Community Planning Group. The three were appealing for denial by the Council halting development.

The appeal was denied, according to Parmer. However, they were granted a concession in requiring the developer, Henegar Homes Inc., to lower height of the condos to 25 feet. The next appeal will be to the Coastal Commission where Parmer hopes CSPRA can gain further modifications lessening impact on Torrey Pines SR.

A critical letter writing campaign is being organized. The City Council hearing generated press and television coverage, which rekindled community interest in acquiring the land for parks. The property is in escrew, so there is still some chance of success.

State Senator Craven has expressed interest in raising the property's acquisition priority IF enough public support is indicated. CSPRA urges you to write asking for acquisition of the proposed Henegar Homes Inc. property & soundary of Torrey Pines State Reserve. Address to Senator William A. Craven, State Capitol, Sacramento CA 95814.
