## **BOARD HEARS DIRECTOR**

Director Pete Dangermond was invited to attend the December CSPRA Board meeting in Sacramento. In a short address to the Board he covered several personal concerns and answered questions from the group.

Dangermond expressed a desire to increase DPR revenues which would offset proposed budget cuts. He asked all DPR employees to stretch services and try to make do with what they had. He asked for ways to increase revenues at the local level to be sent to him.

"It is alright to be a critic" said Dangermond of CSPRA, "but you also have to provide leadership for your members." Dangermond said that working together, CSPRA and DPR could provide the synergistic energy necessary to solve current problems facing parks and recreation in California.

The subject of Lake Matthews in Riverside County was also addressed. CSPRA members may have read Department of Fish & Game article on the lake which appeared in their July-Aug. 1981 issue of "Outdoor California". The author led readers to believe that DPR was going to open up this important wildlife area to water sports, boating, fishing and skiing.

Dangermond said that when he was Director of Riverside County Parks, he wanted to open the 10,000 acres around the lake to public use. He didn't feel locking the area up was the correct attitude by DFG. The County funded a DFG study of the area which Dangermond says showed limited use possible.

Recently the Metropolitan Water District declared their lands adjacent to Lake Matthews as surplus. MWD looked at the possibility of DPR acquisition and took the land off the open market. When the recent Bond Issue passed, Lake Matthews was on the list for acquisition. (It appears as a line item in the Mission 1990 report)



The last issue of the California Ranger should have caught your attention. The article "Proposal for the Re-establishment of the 'Generalist' State Park Ranger" was reprinted much to the delight of the author but without an introduction or any history.

The proposal was written to get some discussion and debate started so that we, State Park Rangers, may be able to address the issue of our careers and not just accept the subtle changes which are taking place that are changing the job of State Park Ranger.

As CSPRA Regional Director, I drafted Resolution 1981-2 for discussion at GEC in Ventura. There was a call in the resolution "that CSPRA take an active role to promote open discussion, poll its members, work with department administrators to study for the next six months the concepts stated this the proposal and that those results be transmitted to all members."

## New Editor

The Board selected Heidi Doyle, a Ranger at Channel Coast Area, to be the new Editor for CSPRA's "California Ranger". Plans discussed included publication twice per year, probably June and December for the professional journal. She will be preparing an article outlining her plans in detail for an upcoming Newsletter. Good luck Heidi!

Dangermond said the planning process for such an acquisition would be guided by the resources and State Park Commission recommendations. He said DPR had no intention of intense development at Lake Matthews. A study by DFG showed recreation use could occur. Fishing could be catch and release. As far as concern over bald eagle sites, Dangermond said the study showed they were there in the winter only.

Dangermond's concern is that adjacent lands be administered for the public rather than having them go for a subdivision. He also sees Lake Matthews becoming a "turf battle" between DPR and DFG for control.

Dangermond said he spoke with the local Warden who told him DFG is managing the lake correctly. He told of "protecting" it by citing over 1,000 people who tried to gain access to the area and of the \$50.00 fine each would have to pay. Dangermond says this is NOT the correct way to manage Lake Matthews, and that the lake should be available on some level to Californians.

A large group of CSPRA members from Lake Perris sent a five-page letter to the Environmental Issues Committee over concerns of a rumored rock concert to be held at the lake. They voiced objections to an estimated 300,000 attendees and associated problems with crowd control, damage to park features etc.

EIC Chairman John Mott had a chance at the December Board meeting to ask Director Dangermond about the rumor. Dangermond said that his office had been contacted by promoters of a "Family Fair" for suggestions on a location to hold their event. They were given several possible sites including Lake Perris. Dangermond said no special event permits had been received and that he doubted the group had any actual backers since they didn't have any performers signed in advance. He said if a proposal was made, it would go through the normal processes beginning at the Area level.

On a related matter, Mott asked Dangermond if it was true DPR was putting a giant water slide at Lake Perris. The Director answered that several proposals from a Regional level brainstor had his attention and that they all concerned methods to expand and increase DPR revenue. Dangermond is determined to increase revenue rather than take budget cuts, as he believes any increases will correspondingly decrease proposed cuts in the DPR budget.


Niel Johannsen, who accompanied the Director, expressed a sincere interest in working closely with CSPRA. (Ed. note - Mr. Johannsen is our newest member!) He felt many problems could be avoided by better communications between the Board and his office.

After the Director left, we learned his father had passed away the day before, and that staff hadn't expected him to attend the CSPRA meeting. Apparently, the opportunity meant quite a bit to Dangermond for him to share his time during this period of grief. CSPRA offers condolences and prayers.

#### GEC EXTRA APPROVED BY DIRECTOR

On the recommendation of Associate Director Russ Porter, Pete Dangermond approved some special extras for those attending 1982 Sacramento GEC. The State Railroad Museum, including the movie and Passenger Station will be open to GEC participants on the evening of Saturday March 8. Hours will be extended to 7 PM allowing conference delegates an opportunity to miss the crowds. There will be no charge to those wearing their GEC conference badges/nameplates.

According to Porter, "Since Sacramento is the host city, we would like to make the State Railroad Museum a major feature of the conference activities." CSPRA thanks Messrs. Porter and Dangermond for their cordiality!!



#### GEC SACRAMENTO 1982

Mike Lynch will teach a 2 hr. Citizens Mace course on Friday morning to anyone interested.

Retired CSPRA members are invited to a noon luncheon on Friday.

Director Pete Dangermond & his staff will open the Friday afternoon session. Following this will be the debut of THE FIELD AND ITS HEADQUARTERS -- A LAUGH-IN EXTRAORDINAIRE,  $1\frac{1}{2}$  hours of vignettes, jokes, hilarity, and maybe even a little clarification on what all those people do at Headquarters. WEW UNIT ADDED



Mono Lake Tufa State Reserve became a reality as of September 1981. One full time and some seasonal positions have been alloted. Currently some question exists as to who owns the land now designated as a State Reserve, State or Federal governments.

The lake itself has not been saved. If current water diversion continues the lake will also continue to decline. What has been preserved are the tufa towers and lake shore area, and eventually the lake bed.

MLTSR is currently under the Sierra Area for management purposes.

In a related matter, EIC Chairman Mott tells Newsletter that the 11 participants made over \$5,000 to save Mono Lake in the recent Bike-A-Thon.

#### USFA Experiment

#### CONCESSIONAIRES WILL OPERATE FOUR CAMPGROUNDS IN STATE

Three of the Sierra's most popular national forest campgrounds will be part of a U.S. Forest Service experiment next year in which camping facilities will be operated for "reasonable fees" charged to users by private concessionaires.

The campgrounds are French Meadows Reservoir and Jackson Meadow Reservoir, both in Tahoe National Forest, and Pinecrest, in Stanislaus National Forest.

The three are among four throughout the state that will be included in a nationwide attempt by the Forest Service to cut maintenance and operation costs because of budgetary restraints in Washington, D.C. according to Frank Waldo, regional Forest Service recreation expert in San Francisco.

EDITOR'S NOTE: THE WAVE OF THE FUTURE FOR STATE PARKS DURING STATE CUT-BACKS?

Officials of the state Department of Parks and Recreation, the other major operator of campgrounds in California, expressed fears that user fees would rise substantially if concessionaires are used.

"They are not often a good idea," parks director Pete Dangermond said.

The state, he said, has about 180 individual concessions, like grocery stores and canoe rentals, but has tried only three park concessions, and they did not work well.

Neil Johannsen, deputy director and chief of operations, said it takes \$70 million annually to operate the state parks system, and user fees return only a third of that. "The private sector has not found it cost effective," he said.

The Forest Service program probably will mean an increase in user fees and a decrease in such traditional things as nature walks and campground programs, Johannsen said.

Senate Bill 1220 (Craven) is an attempt to withdraw further Los Penasquitos State Preserve watershed lands from the Coastal Zone near San Diego. This will deny Coastal Commission rutiny of land use activities in a major portion of this unique coastal werlands watershed. The San Diego Association of Governments has recently completed a Penasquitos Lagoon Watershed Management Plan to deal with the deteriorating water quality problem in the lagoon. This requires solution through the coordinated actions of several agencies including DPR. The lack of involvement by the Coastal Commission, if this bill reaches the Senate floor and passes, will seriously hamper this management effort. The bill will be heard in the Finance Committee in January 1982. Members are urged to drop a short note to Chairman; Alfred Alquist; 777 North 1st St., San Jose, 95112, opposing this bill. Our letters can make a difference on this one.

#### THE \$25.00 BOOMERANG




