Bullet Train to Pierce Park


Recently the American High Speed Rail Corporation proposed a new transportation mode to be constructed between Los Angeles and San Diego. This "bullet train" will carry passengers between these two urban centers in 1 hour at speeds up to 160 MPH.

The proposed route parallels existing Santa Fe Railroad easements in some areas and will use new routes in others.

It is the route of the train which has drawn most of the public attention. In Northern San Diego County the train would hug fragile bluffs near Del Mar, cross several coastal lagoons and pass through the area of highest wildlife density at Torrey Pines State Reserve. Planning of the high speed rail system has so far been excluded from any environmental review process. This has spurred the introduction of Assembly Bill 4 which would give affected communities the right of veto over the project. At present the bill is scheduled before the Transportation Committee at the beginning of May 1983.

The effects of construction on the bluffs and lagoons or the effects of increased noise on the habitats, person or animals have never been addressed. It is this lack of Park Lands Bond

CSPRA would like to commend Assemblyman Sam Farr (D-Monterey/Santa Cruz) for his introduction of AB 2099 (The Park Lands Bond Act of 1984). The proposed legislation, which must pass both state houses, and be signed by the governor before facing a public vote, designates 60% of the funding for acquisition of park inholdings and development. The remaining 40% is slated for local park projects through grants. To date it has passed its first Assembly committee hearing and is expected to come to vote around June 15th. If it is successful in clearing initial hurdles, it will be' heard in the Senate and hopefully appear before the voters in 1984.




CALL FOR PAPERS: 1984 INTERPRETIVE CONFERENCE

information which has caused us to take notice of the situation.

As a CSPRA member I'm proposing that the association support an effort which would delay construction of the project proposed by the American High Speed Railway Corporation until adequate studies have been made to determine short and long term impacts of the development. This is not to say that our organization does not support efficient mass transit, but that the trade-offs should not be the coastal environment. Further, the issue of public control of projects designed for the public's benefit is at stake.

Although still in the planning phase, construction is predicted to start late next year with full operation expected by 1988.

I urge members to contact their assembly representative to support AB4.
