


Bypass to Bisect Montara State Beach



The recent acquisition of additional land for Montara State Beach has been threatened by the possibility that the State Department of Transportation may opt for a realignment of state route one which bisects the parcel. The McNee Ranch addition to Montara State Beach consists largely of the steep, rugged granitic ridges of Montara Mountain, which provide magnificent vistas of the San Mateo coastline. The property also has the potential of providing a massive, unspoiled coastal mountain trail corridor. If the National Park service acquires their proposed Sweeney Ridge addition to the Golden Gate National Recreation Area. Montara State Beach could be the trailhead for a spectacular outing spanning portions of one National and three County of San Mateo park The continuity of such an open space corridor could only be heralded by future generations.



known as Devil's Slide, which lies between Montara and Pacifica along the San Mateo Coast. Devil's Slide is a steep. unstable section of the California coastline. The present route of State Highway One transverses several active landslides. During heavy winters this segment of Highway One frequently closes. In the winter of 1983 large cracks occurred in the pavement and roadway settlement, up to six feet in some locations. made Highway One impassable. This road segment was entirely closed from March 4th to May 27th 1983.

CSPRA believes that a proposal to modify the existing road alignment to negate the effects of the reoccurring slides is the best alternative. At the January meeting of the CSPRA Board of Directors, CSPRA Resolution 84-1 was adopted (the full text is on page four) which will formally notify the California Department of Transportation of our position.



CSPRA RESOLUTION 84-1
DEVIL'S SLIDE BYPASS - MONTARA STATE BEACH

WHEREAS, California Department of Transportation is currently seeking relocation alternatives for highway one from existing landslide - prone "Devil's Slide" adjacent to Montara State Beach, and


WHEREAS, one of the current alternative remedies proposed. The "Existing Alignment" (also known as the Marine Disposal Alternative) appears less damaging to the coastal environment, has the least damaging impact to scenic, natural and operational values of Montara State Beach, and


WHEREAS, the other alternatives (Adopted Alignment and Martini Creek Alignment) would bisect the recently acquired McNee Ranch portion of Montara State Beach, therefore be it

RESOLVED, CSPRA President write Marie Pang, CalTrans, P.O. Box 7310, San Francisco 94120 (before closing of the open comment period on February 23, 1984) and go on record supporting the "Existing Alignment Alternative" and request that a scaled-down alternative be explored as the best possible choice, and be it further

RESOLVED, that CSPRA encourage the Department of Parks and Recreation to support the Existing Alignment Alternative as the least objectionable choice.

Reflections on a Conference

With the joint conference of WIA/CSPRA/PRAC rapidly approaching, I would like to take this opportunity to share with CSPRA members my experiences at a similar conference last September at Mammoth Lakes, CA. The Association of Interpretive Naturalists (AIN) held their regional workshop in the perfect setting for a conference on "Interpreting Controversial Issues."

As many of you may know, the Mammoth Lakes region is the site of renewed geologic activity. Specifically, earthquakes have trembled through the area at rates of up to hundreds per day, possibly signifying renewed volcanic activity (which was originally responsible for the present topography). Mono County Supervisor Al Leydecker outlined the emergency evacuation measures he had implemented (including a new access road to the mountain community) in the event of more drastic and life threatening volcanic activity. Mr. Leydecker, incidentally, was the target of a recall petition because of his efforts on behalf of all the residents and visitors to the Mammoth Lakes area. Talk of controversy! Mr. Leydecker also conducted a fascinating and extensive tour of the area to point out the geologic history.

Within one hour's drive north lies Mono Lake, one of California's most spectacular natural features and the site of a nationwide controversy concerning its future. Our own David Carle, representing the California State Park System from the Mono Lake Reserve, sat on a panel discussion with a representative from the Los Angeles Department of Water and Power, and David Gaines, President of the Mono Lake Committee. Each representative outlined their position on this sensitive subject.

Afterward, those attending all piled into a big yellow bus and headed for the lake. Janet Carle, another state park ranger at Mono Lake, gave a fascinating interpretive introduction to the lake and its magical tufa formations. Quite a few of the naturalists took the opportunity to swim in the highly alkaline lake (including me). It proved to be a very buoyant experience! Happy, tired and ghostly white from the alkaline we boarded the bus back to camp.

If the days were busy and filled with stimulating conversation, the nights were filled with camaraderie and good times. Dancing, drinking, playing music and singing around a campfire were just some of the evening's activities. Naturalists came from as far away as Michigan, Colorado, and the East Bay of San Francisco to share ideas and have a good time. Many agencies and organizations were represented: California State Park System, National Park Service, East Bay Regional Parks, Yosemite Institute, and two nature centers from Colorado all had healthy representation. The feeling that we all were sharing in a common goal and interest ran high. The enthusiasm for interpretation

and the enjoyment of the outdoor environment created an instant rapport among the participants. By the end of the conference everyone agreed it was a fantastic experience both personally and professionally.

For me, I have been lucky enough to have been granted renumeration by the CSPRA Education and Training Committee. CSPRA realizes the importance of interpretive training events and supports its members' efforts by offering financial support. Not only was the conference a fantastic learning experience, but CSPRA helped support my enthusiasm for this kind of training by offering financial support.

I would like to encourage park personnel to take advantage of conferences and meetings which contribute to professional excellence and personal growth. Organizations like CSPRA are also there to help members when the department cannot. My thanks go out to Steve Horvitz and the Education and Training Committee for their support and encouragement!

Tax Advantage of Conventions

Do you realize that attending the annual convention will not cost as much as it appears? IRS Publication 17 (free from the IRS) states under "Employee Business Expense": "You may deduct travel expenses...to attend a convention if you can show that your attendance benefits your own work or business..."

Food, lodging, transportation (current real costs or $20 \phi/\text{mile}$) and registration are entered on Form 2106 and are deducted from gross income. You do not have to itemize deductions in order to take this "adjustment" to income. Remember to be fair to the tax collector. If part of your motivation for attending the convention is social or for personal reasons, that percentage cannot be deducted as a business expense (i.e. banquets, beer testing, golf and pistol tournaments are not deductable - they do not benefit your work).

Remember:

- 1. Keep records and receipts of your expenses for attending the 1984 Joint Conference.
- 2. Contact your IRS office for Publication 17 and Form 2106.
- 3. Contact a CPA or the IRS if you have any questions.
- 4. Write off your legitimate expenses when you file your 1984 tax return.

Don't forget to claim legitimate expenses for attending the 1983 conference at Reno on this year's tax return.

A possible option is to attend the March 1984, 36th annual, Recreation and Park Conference sponsored by the California Park and Recreation Society, National Recreation and Park Association, and the City of San Diego. Board Highlights

The January Board Meeting, held in Santa Cruz, was attended by both the newly elected officers and the outgoing Board. This arrangement helped ensure a smooth transition between officers.

**Preparations for the March CSPRA/WIA/PRAC Joint Convention are going well. with 400 - 500 people expected to attend. The 1985 Convention will be held in southern California: no definite location vet.

***Education and Training Committee: Steve Horvitz was commended by the Board for his outstanding work as chairman. Because so many scholarship requests are coming in, the Board voted to limit awards to \$200.00 per person per year. A DPR 392 (Employee Training Request) is no longer required to be submitted with a scholarship request.

**Continuing their regular meetings with the DPR Director, President John Mott and President-elect Jeff Price will have met with Director Briner on February 3.

***Park Integrity Committee: This new CSPRA committee will concern itself with threats to the integrity of State Park System units. At the request of the family, unpaid rewards will be used to purchase a memorial at Big Basin Redwoods State Park through the Sempervirens Fund. Sempervirens Fund is a respected conservation organization dedicated to completing Big Basin and Castle Rock State Parks.

Confirmation Hearing

The Senate Rules Committee has set February 22, 1984 as the date opening appointed Department of Parks and Recreation Director William Briner's hearings for confirmation. Senator Roberti, chairman of the Senate Rules Committee, will oversee the confirmation hearings of the Governor Deukmejian appointee.

ENVIRONMENTAL UPDATE

REQUIEM FOR A LAWSUIT As reported in the January Newsletter, CSPRA was one of 22 conservation organizations which joined to sue the Interior Department in order to block lease sale #73. Two years ago a similar suit involving lease sale #53 was appealed to the U.S. Supreme Court. In January the court ruled that while drilling may damage the marine environment, lease sales themselves (the exchange of money for marine tracts) have no impact. In one stroke both lawsuits were defeated. Also, now that the oil lease sales do not have to be shown to be consistent with the Coastal Zone Management Plan, all lease sales can proceed unimpeded. The only thing blocking lease sale #80 in southern California and lease sale #91 in northern California is a one year moratorium on sales in this area that was included in the Interior Department's Appropriations Bill. This temporary moratorium expires in October 1984. There are several avenues CSPRA and other groups will be pursuing to block the development at that time:

- 1. Renew the moratorium in the next Interior Appropriations Bill for fiscal year 1985.
- 2. Pass a permanent moratorium bill.
- 3. Pass federal legislation that will strengthen the Coastal Zone Management Plan and extend its authority to pre-drilling phases of oil recovery, such as the lease sale itself.

SECRETARY CLARK In a highly publicized pronouncement, Secretary of the Interior Clark says he will delay lease sales #80 and #91 (see above). It was a wise decision on his part since it would have been illegal to do otherwise. Both of these areas are included in a one year moratorium on lease sales passed by Congress earlier in the year. He also announced he would increase the amount of money for NPS land purchases to \$150 million. This is not really an increase since this is precisely the amount that Congress has allocated for NPS purchases for the past few years. The difference is that Watt always returned a great deal of the money to the General Fund. Under the Carter Administration \$700 million was spent in one year for NPS acquisitions.

Commissioner Victoria Araujo has been endorsed by two additional organizations urging Governor Deukmejian to reappoint Ms. Araujo to an additional term on the State Park and Recreation The Hispanic Recreation Commission. and Leisure Services Association endorses her reappointment stating, "Ms. Araujo has served all the citizens of California admirably on the Commission." The San Francisco based organization entitled People for Preservation of the Natural and Wild in Bay Area Open Space wrote to Governor Deukmejian praising, "She has displayed an uncommon concern for the integrity of our parks and beaches and for the people who use them." CSPRA has previously endorsed Ms. Araujo's reappointment in writing, and hopes that Governor Deukmejian promptly will confirm her stay on the Commission for an additional term.
