Local Camping Taxes By Tom Nixon

As of July 1, 1984 Visitor Services employees of Carpinteria State Beach have been collecting and accounting for transient-camper taxes as implemented by order of the Carpinteria City Council and adjudicated and decreed by the Superior Court of the state of California for the county of Santa Barbara. In effect, anyone who now wishes to camp at Carpinteria State Beach must pay in addition to their regular camping fee or reservation an 8% tax on the dollar for each day of their stay. Exclusions to this camper's "bed tax" are day use fees, dog fees, extra vehicle fees, and other exemptions outlined in chapter 3.36 of the Carpinteria Municipal Code. City representatives indicate this tax is necessary to pay for services the city provides for the state park such as police and paramedic assistance.

Discussion of implementing such a tax ordinance has been ongoing for some time. A hearing was held on February 10, 1984 before the Honorable Patrick L. McMahon in which the city tax ordinance was held valid under California law. Transcripts from the hearing indicate that the state failed to provide representation at the hearing. Closer inspection reveals that the city met its commitment pursuant to the Code of Civil Procedure for "summons by publication" to all interested parties, yet this amounted to little more than an announcement in the local paper. Channel Coast District and Carpinteria State Beach offices have no record of receiving any notification of the hearing.

In addition to the case of Carpinteria, Local Jurisdiction Camping Taxes, (LJCT) are beginning to appear in other areas of the state park system. South Carlsbad has begun collecting LJCTs at a rate of 6% to the dollar. Other areas dealing with LJCTs in one form or another are Morro Bay (8%), and Pismo State Beach (7%). The Napa Area has also been rumored to be involved. A visitor recently told me that he was able to vote on a referendum for such an ordinance in the Santa Cruz Area.


Retired CSPRA Golfers







The Department has issued notices for proper collection of such taxes. The Administrative Manual section 0623 is in the process of being revised to include the additional accountability as are the 1985 Group and Family Reservation applications for camper notification. Permanent signs are being designed and ordered for park user information. LJCTs are rapidly being integrated into the state park system.

What effect will these "bed taxes" have on the state park system? Most importantly, how is the public receiving these additional taxes?

Operationally there are many concerns. Since collections are subject to local audit, tax collections must be stated individually on receipts. A camper coming in with a reservation with no extra vehicles or dogs must stop, pay and receive a receipt for a tax. This creates more of a workload at the entrance station. Sufficient change is continually needed and must be sought often. Report of collections are taking much longer, taking rangers out of the field. Finally there is a general concern being voiced as to how effective are we as a tax collecting agency and to what degree are we adding to an administrative workload that has been already criticized as occupying too much of park operations.

The feedback from the public has almost all been negative. Some campers refuse to pay and leave, while others complain and stay. One general comment is often heard, "How can the city tax the state?" The general frustration expressed by the camper centers on a bewilderment as to why this is being allowed to happen. "Since state parks are already being subsidized by taxes," one camper asks, "why am I being taxed again?" Campers are having a hard time seeing what services are being offered to them by local communities. Conversely they feel as if it is they, through their tourism dollars that support the local economies. The Department has lacked any real evidence for some time to adequately report on how park visitors support local economies. This is currently being rectified by Park Visitor Spending Surveys which are being distributed at many designated state park units.

Taxes are a volatile issue. Our ancestors went to war over it. Rangers and park aides are spending a great deal of time mustering up all their interpretive skills to respond to the anger and frustration. For us in the field, we are wondering what price the state park system is paying in public relations. More importantly, what is being done to satisfy a recreating public that supports parks and continually passes Bond Acts (such as the recent Proposition 18)?



As a solution one camper has indicated that he intends on contacting his Assembly person and having his representative initiate legislation to overrule current ordinances and to prevent local jurisdictions from taxing state park units within their boundaries. Other campers have taken advantage of the recent Park Visitor Spending Surveys to vent their feelings. Some campers have threatened petitions and boycotts of local merchants. This has failed to materialize to my knowledge. The most recent concern being expressed by both camper and department employee is that camping fees will be raised to absorb the LJCTs. This will alleviate many operational concerns, but how will this sit with campers?

As a ranger entrusted to protect the parks, serve the public and interpret the whole thing, I find myself concerned and admitedly lacking in information as to how to best support the department and the values of the state park system as it relates to the controversy generated by LJCTs. Local communities and state parks should be able to co-exist and to draw from the support each has to offer the other. Let us not forget the public in our efforts to work out our economic relationships. We exist because of them.


