

Utilize telephone surveys and polls frequently. (To this end we are considering the use of an 800 number.)

Update on Bodie — Galactic Bankrupt by Donna Pozzi

On January 27, Galactic Resources, Ltd. of Vancouver filed for bankruptcy in Canada. There had been earlier filings of their American subsidiaries. Galactic Resources, Inc. and Summitville Consolidated Mining Company, and the parent company was expected to follow suit. Nonetheless, this is still exciting news. Galactic had been aggressively pursuing the sale of their holdings at Bodie and we were dreading a buyout by another mining company. Now a bankruptcy trustee has been appointed to meet with (Continued on page 3)

President's Message

By tradition, this is the time of year when the CSPRA president offers the official New Year's Wish to all members, so here it goes:

I Wish For All of You to Attend GEC!

That's the trouble with traditions — they're always over so fast. Although I suppose I could vamp a bit, and tell you how this will be the best ever, etc. The "best ever" is, of course, a matter of taste and/or lack thereof. For instance, there is no guarantee that Mike Lynch will conduct the banquet raffle. But it will have our own special California State Park blend of good cheer, education, pathos, and opportunity for you to tell one and all just how this business of ours should be run.

Seiously, the PRAC/CSPRA Workshop Planning Committee has put special effort into making this convention/workshop appropriate for our times and trials. Last year's GEC was caught off guard by looming budget cuts, reorganization, and threatened layoffs — seeming to many of us as slightly surreal. Our hope is that this year's GEC will be ready to confront the critical issues we are facing, and give us a chance to learn more about how we are to function as park professionals in a drastically revised system.

It would have been silly for us to join the current trend in conference planning, and declare as a theme "State Parks 2000: Facing The Recreational Needs of a New Millenium!" A more apt theme might be "What next?" The point is, we hope that this year's conference will give us a much needed opportunity to get together, talk things over, and maybe reinforce that important but lately strained institution: the park family.

I hope that the Santa Clara GEC will also provide an opportunity to present the New, Improved CSPRA. The draft proposal on revising our organizational structure should be finished by the beginning of February, and will be considered at the February 6 meeting of the Board of Directors. As mentioned before, the intent was to revamp CSPRA so that field participation is enhanced, thus reducing the tendency for our association to exist only as a Board of Directors for most of the year. GEC will give you all the chance to review and comment on the proposed changes.

As was the case in 1988, the Planning and Conservation League (PCL) is preparing a park and conservation bond initiative. Scheduled for 1994, this proposal is the next opportunity for the State Park System to obtain valuable funds for acquisition, development and resource management. Unfortunately, a recent law forbids any group that might benefit from an initiative from participating in its planning. This meant that if CSPRA had actively proposed or supported any project covered in the bond, we could not have worked with PCL on its design. We opted to join the PCL Initiative Steering Committee, relying on other organizations to propose those projects of vital interest to the California State Park System. Our representative to the committee, John Knott, and the other members have their work cut out for them; the initial list of projects submitted from all over the state worked up a tab of over \$9 billion dollars.

"This is not a guidebook," Carle explains in his introductory chapter. "Yet I set out to inform. Environmental education is a part of my job as a ranger, after all." He then leads the reader through each of the four seasons to a final philosophical section called "In Search of Happily Ever After."

Above all, Carle maintains an imaginative approach to his material. In the beginning, he gives us our first cooking lesson on how to make Mock Mono Lake Soup (create a little of Mono Lake in your very own home!) The section "Spring" celebrates the life cycle of one of Mono's tiny creatures in "The Once And Future Shrimp," a take-off on the T.H. White classic, complete with Merlin the Magician.

For anyone who has not yet explored Mono Lake in summer, the essay "Take a Tour" prepares you for the experience. Here are Tufa towers, the "shy" alkali flies, California gulls, Mono's young volcanoes, and much more. "The Mystery of the Red-eyed Bird" is revealed in the section "Autumn," and "Winter" brings "Ouzel Omens."

Carle has ingenuously turned this book of facts and expertise into delightful tales of the Mono Basin to be shared by everyone.

all the creditors and liquidate the company. The trustee plans to visit Bodie soon since Galactic's claims and leases there represent their major assets. There is a small window of opportunity for these properties to be acquired for preservation purposes, or they could be bought by another mining interest.

The Draft Environmental Impact Report for new exploratory work at Bodie is still awaiting action. Comments are due March 1. While we hope the trustee will withdraw Galactic's permit application and suspend the DEIR process, we cannot count on that and must continue with our critique of the draft. CSPRA's attorneys have solicited comments from a variety of experts and expended a great deal of effort in analyzing the voluminous document. Meanwhile, Mono County and the Bureau of Land Management have initiated a joint planning effort for the Bodie area and are in the process of appointing a citizens advisory committee.

The Bodie Protection Act of 1993, HR 240, has yet to be heard in subcommittee but we are hopeful that it will be acted on soon. We are also looking forward to introduction of the Senate version of the bill. This legislation is extremely critical now because of Galactic's bankruptcy. The bill would prevent another mining company from filing new claims on the public lands surrounding Bodie.

and other time-sensitive material that does not fit into a newsletter timeframe.

Establish a small committee to continue efforts to expand membership involvement.

Establish District Representatives to provide a contact person between the membership and board to provide better com-(President Harrison has munications. asked Joe von Hermann to establish this procedure.)

Increase the effectiveness of the newsletter.

Request members to attend park commission and other meetings.

Initiate and sponsor local activities (recreation, social, professional training, and political) on a regular scheduled basis. (Harrison appointed Rick Sermon to develop a workshop along the central coast for this fall to start this program.)

Recruit members for specific projects, especially for local issues and activities.

Sponsor campouts, picnics, hikes and other outings. Possibilities include "working events" such as resource management, rehabilitation, and trail projects. (We can learn, have fun, and do some good for a park at the same time.)

Poll membership for "resident experts."

Sponsor training that had been offered at Asilomar and has now been cut.

Revive the Ecology Workshops that used to be provided in interpreting regional habitats.

Establish a "Letter of the Month" program. Provide information and contacts on one major issue each month and ask members to write a brief letter or call the contacts listed in support or opposition of the issue.

Require regional representation on the board.

Establish "sunset dates" for all committees and chairpersons, thereby requiring board action to continue them.

Establish goals and objectives annually.

Develop an annual report that would recap the years activities and accomplishments.

Explore the need and feasibility of standards for accountability of board members and committee members. Items that should be considered for inclusion are: attendance at scheduled meetings, completion of required reports, and other activities.

Summary: Common themes expressed by CSPRA members were.

Improve and increase activities of all types — regional activities received very strong support.

Improve responsiveness to local issues.

Improve communication between the board and the members.

There was strong support for political action and the "watchdog" role of CSPRA.

A willingness to commit to local and specific projects was frequently expressed.

Discussed our role on the PCL bond initiative review committee. John Knott is representing us on this committee whose task it is to select 2 billion dollars worth of projects from approximately 9 million dollars worth of projects submitted.

Charlie Willard made a presentation encouraging the board to continue opposition to the Lake Natoma bridge since the local political climate has changed. CSPRA will continue to oppose this particular route.

Selected a honorary member to be announced at the annual conference in Santa Clara.

Chose the Riverside Sheraton as the site for our 1994 annual workshop/GEC.

The next board meeting will be at the Santa Clara Biltmore on March 4 at 0830.

What's this, a divine float happening? "He's going to occur the raft of God!




