CSPRA Sends Letters

May 8, 1996 Senator Dianne Feinstein

Re: 1996 Water Resources Development Act — Oppose the Auburn Dam

Dear Senator Feinstein:

As part of the 1996 Water Resources Development Act, the Auburn Dam on the American River in California will be considered. The California State Park Rangers Association opposes the Auburn Dam Project.

The Auburn Dam would destroy more than 40 miles of the American River. Much of this area is currently under the management of the California Department of Parks and Recreation and is used by rafters, fishermen, hikers, and for wildlife observation. There are flood control alternatives that would not have the environmental impacts of the proposed 508 foot-high dam.

The proposed dam would not only cause severe environmental impacts, but it would also have severe economic impacts. Considering that there are alternative flood control measures available at half of the cost, it seems foolish to use one third of the available flood control money in the United States on this project.

Presidents Message

Park bonds have existed as a funding tool for our Department for many years. Bond money has allowed us to do things that our normal budget process does not include. Historically this has meant money for acquisition, development, resource protection and various enhancements.

Although not all park bond money has gone to State Parks, our Department has administered most of it through the local grants program. Many of the recent "park bonds" have included a great deal of money for habitat and open space acquisitions by land trusts, conservancies, and open space districts. This has resulted in very large bonds that have included considerable chunks of money for acquisition of all kinds, and they have been rejected by the public.

Private efforts, in sum, are no substitute for public funding.

On May 12th the Assembly Water, Parks and Wildlife Committee consolidated 2 bond bills into a measure that would fund local and state park restoration, long term maintenance and infrastructure rehabilitation. This measure passed out of committee 10-0 and received support from both sides of the aisle. CSPRA Board Member Stephen Hill testified at the hearing and was pleased with the results. The real work is just starting, and I urge everyone who is interested in helping get a park bond passed to contact a CSPRA Board member.

And why is a Park Bond so important now? Bob Hansen, Executive Director of the Yosemite Fund, says it best in a recent article in Sunset Magazine. "Groups like ours can't do more than enhance the system. We can't completely patch up holes in the safety net of public funding, or even begin to address the deeper core problems facing the parks today — increased visitation, decaying infrastructure, facility maintenance." As the article goes on to say, if that's true of Yosemite, it's doubly so for other parks, few of which can boast such a reservoir of public affection or muster a comparable level of corporate or citizen support. Private efforts, in sum, are no substitute for public funding. It can be argued that bonds are not the most efficient use of public funds, but at the moment a November Parks Bond appears to be our best chance of increased public funding. With your help, that could become a reality.

This scholarship fund is designed to augment or in many cases provide the funding necessary to obtain training that benefits the applicant in his or her park career.

Currently our department's budgetary woes have eliminated or drastically reduced the amount and type of training available to its employees. The CSPRA scholarship attempts to reduce the impact of that lack of funding in order to benefit the employee and to benefit the Park System by encouraging better trained and motivated staff.

The CSPRA scholarship program provides any member of CSPRA with up to \$200 per year for the training of their choice. Criteria for receiving scholarship funds are rather broad. For example: will the training be a direct benefit to the employee? Will the training be a benefit to the Department? Will the training be a benefit to the applicant's career with DPR? Tough criteria? No. CSPRA's goal is to ensure that its members get as much support in improving skills, knowledge or viewpoints as possible with the final objective; a skilled and knowledgeable park professional.

Are there limitations to this program? Yes. The current funding level of CSPRA only allows for a maximum of \$200 per member per fiscal year. Beyond that level of funding, the applicant must ask the Board of Directors for further financial assistance. Each recipient receives only half of their scholarship immediately upon approval and the balance after an article has been written and sent to the editor of the Newsletter. The article must be 200-750 words in length. The

article should bring out those points of the training that best benefits the membership. In this way all CSPRA members will gain from the training!

How does one get a scholarship? Write your request in letter form or on a printed scholarship application (see page 5). Include any brochures or pertinent information about the training requested. Send a copy of your DPR 392 – Training Request showing that you have attempted to get departmental funding for the training. Don't be discouraged if the department turns you down or only partially funds your training. CSPRA's goal is to see that if at all possible, you, a CSPRA member, get the training you need.
